## **TECHNICAL SPECIFICATIONS**

1. The 'V' neck pullovers shall be made of ribbed heavy woollen army type, 100% wool.
2. Pullovers are to be supplied dark blue in colour, with shoulder and elbow reinforcements (pads) of the same colour, epaulettes 5cm wide, round edge and with a velcro closing patch 2 square cms.
3. The label of each pullover being supplied is to include the size, wool content, and the letters 'G.M.'.
